Motion was made by Stanbrough and seconded by Tellin to set the date for the first reading of the proposed Amendment to Ordinance #36. An Ordinance regulating the placement of commercial wind energy conversion systems on property located in the unincorporated areas of Fayette County, Iowa for Monday, April 8, 2019 at 9:15 A.M. in the Boardroom of the Fayette County Courthouse.

On roll call, all voted aye, none nay, and the motion was carried.

The Board met with Joel Fantz, County Engineer, for a secondary roads update.

Motion was made by Tellin and seconded by Stanbrough to approve the Striping Contract to Vogel Traffic Services in the amount of \$41,654.58. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Tellin and seconded by Stanbrough to approve the FY 2020 Secondary Road Iowa DOT Budget. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Stanbrough and seconded by Tellin to approve the FY2020 Five Year Construction Program. On roll call, all voted aye, none nay, and the motion was carried.

The Board met with Mike Recker, Paul Ganske and Eldon Knoploch for a discussion regarding the stop signs on Outer Road and 1st Street NE in Oelwein and also a discussion regarding the No Snow Removal Roads in the southern part of Fayette County.

The Board met with Bruening Rock for a discussion regarding the County Roads.

Motion was made by Stanbrough and seconded by Tellin to approve the following license: The application of Paul Manske, d/b/a Corner Market and Greenhouse for a 12 month Class B Native Wine Permit with Sunday Sales for use in Jefferson Township was submitted and recommendation made that the license be granted. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Tellin and seconded by Stanbrough to adopt the following resolution:

Resolution # 401

A RESOLUTION TO TERMINATE A 28E AGREEMENT BETWEEN FAYETTE COUNTY AND FAYETTE COUNTY ECONOMIC DEVELOPMENT COMMISSION.

WHEREAS Fayette County Board of Supervisors, a governmental agency existing under the laws of Iowa with its office at 114 N. Vine Street, West Union, IA, has chosen to terminate its economic development agreement with the Fayette County Economic Development Commission.

WHEREAS, in following the tenets of the joint 28E agreement originating November 1, 1988, between Fayette County, County of Fayette, the Fayette County Banker's Association and Public Utilities Companies, notice to terminate is hereby given and shall go into effect on June 30, 2019 at the conclusion of the current fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE FAYETTE COUNTY BOARD OF SUPERVISORS:

In witness whereof, the Fayette County Board of Supervisors have executed the termination of this agreement as of the date listed above.

On roll call, all voted aye, none nay, and the resolution was adopted.

The Board met with Economic Development.
