**RESOLUTION #377
POSTING WEIGHT LIMITS ON FAYETTE COUNTY
STRUCTURES:**

Whereas, the Fayette County Road Department, following the guidelines of a continued structure inspection program; and

Whereas, all bridges are inspected, analyzed, and rated per National Bridge Inspection Standards;

Therefore be it resolved by the Fayette County Board of Supervisors upon recommendation of the County Engineer that load limits for all vehicles be established on the following structures and their approaches, and that the load limits shall be legal, valid and enforceable under the applicable provision(s) of the Code of Iowa, effective immediately upon placement of load limit signs. Additionally, the load limits shall be for All Vehicles, including agricultural vehicles, and shall be signed with an “All Vehicles” placard.
