A RESOLUTION OF THE FAYETTE COUNTY BOARD OF SUPERVISORS
ADOPTING

THE 2018 FAYETTE COUNTY, IOWA MULTI-JURISDICTION (MJ-14) MULTI-
HAZARD MITIGATION PLAN

WHEREAS the Fayette County Board of Supervisors (Board) recognizes the threat that natural hazards pose to people and property within Fayette County; and

WHEREAS the Board has prepared a multi-hazard mitigation plan, hereby known as the “2018 Fayette County, Iowa Multi-Jurisdiction (MJ-14) Multi-Hazard Mitigation Plan” in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS the “2018 Fayette County, Iowa Multi-Jurisdiction (MJ-14) Multi-Hazard Mitigation Plan” identifies mitigation goals and actions to reduce or eliminate long term risk to people and property in Fayette County from the impacts of future hazards and disasters; and

WHEREAS adoption by the Board demonstrates their commitment to hazard mitigation and achieving the goals outlined in the “2018 Fayette County, Iowa Multi-Jurisdiction (MJ-14) Multi-Hazard Mitigation Plan.”

NOW THEREFORE, be it resolved that the Fayette County, Iowa Board of Supervisors approves and adopts the “2018 Fayette County, Iowa Multi-Jurisdiction (MJ-14) Multi-Hazard Mitigation Plan,” as an official plan.

On roll call all voted aye, none nay, and the resolution was adopted.

The Board met with Carol Keune for a review of the Fayette County Civil Service Budget and a budget request.
