Ben Daleske had an Assistant to the Engineer – Education and Training Pay Scale Evaluation on 6/23/17 - \$0.50 per hour increase base on milestones completed. Wage will increase to \$22.15 per hour.

Megan Robbins had an Administrative Assistant Education and Training Pay Scale Evaluation on 6/23/17 - \$0.42 per hour increase based on milestones completed. Wage will increase to \$21.06 per hour.

Eli Phillips will have 5 years of employment, Union Contract longevity increase of \$0.15 per hour. Wage will increase to \$20.35 per hour.

The Board met with Carrie Davis, Tourism and Sam Whitehead, Economic Development for updates.
