Motion was made by Bradley and seconded by Dolf to approve the snow removal bid from Clines Construction for the removal of snow on the Courthouse parking lot. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Dolf and seconded by Bradley to approve the Black Hawk Waste Disposal Service Agreement at a rate of \$45.00 per month for a one year contract at the guaranteed price. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Dolf and seconded by Bradley to approve the Fayette County Collective Bargaining Agreement Contracts with Lynch Dallas at a cost of \$3,000 per

each contract for each of the four units; Secondary Roads, Sheriff's Office, Conservation and Solid Waste. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Bradley and seconded by Dolf to approve the purchase of two additional garage doors for the Courthouse Garage from Spahn and Rose with a cost of \$1,298.00. On roll call, all voted aye, none nay, and the motion was carried.

The Board met with Joel Fantz, County Engineer, for a Secondary Roads update.

Motion was made by Bradley and seconded by Dolf to approve the supplemental pay market adjustment for mechanics. Eli Phillips, Bud Johnson and Richard Rausch effective with the current payroll will each receive a \$.80 per hour increase added to the Mechanic 1 or Mechanic 2 base wage. On roll call, all voted aye, none nay, and the motion was carried.

Effective 10/16/2018, Alex Hertges has been hired as a Temporary Part Time Detention Officer for the Fayette County Sheriff's Office. His wage will be \$14.92 per hour.

The Board adjourned.
