

Fayette County Election Precinct Ordinance #30

An ordinance clarifying the election precincts established on October 29, 2001 and amended on October 31, 2005 in Fayette County, Iowa.

Section 1. REPEAL. The list of precincts established by ordinance on October 29, 2001 and amended on October 31, 2005 is hereby repealed.

Section 2. Adoption. BE IT ORDAINED AND ENACTED by the Supervisors of Fayette County, Iowa that the county be divided into the following precincts:

Auburn Township Precinct: includes Auburn Township and the city of St. Lucas

Banks-Fremont Township Precinct: includes Banks and Fremont Townships and the city of Westgate and the city of Sumner within Fayette County

Bethel-Windsor Township Precinct: includes Bethel and Windsor Townships and the city of Hawkeye

Center Township Precinct: includes Center Township and the city of Randalia

Clermont Township Precinct: includes Clermont Township and the city of Clermont

Dover Township Precinct: includes Dover Township

Eden Township Precinct: includes Eden Township and the city of Waucoma

Fairbank Inc. Precinct: includes the city of Fairbank within Fayette County

Fairfield-Putnam Township Precinct: includes Fairfield and Putnam Townships and the city of Arlington

Harlan Township Precinct: includes Harlan Township and the city of Maynard

Illyria Township Precinct: includes Illyria Township and the city of Wadena

Jefferson Township Precinct: includes Jefferson Township excluding the city of Oelwein

Oelwein First Ward Precinct

Oelwein Second Ward Precinct

Oelwein Third Ward Precinct

Oelwein Fourth Ward Precinct

Oran Township Precinct: includes Oran Township excluding the city of Fairbank

Pleasant Valley Township Precinct: includes Pleasant Valley Township and the city of Elgin

Scott Township Precinct: includes Scott Township and the city of Stanley within Fayette County

Smithfield Township Precinct: includes Smithfield Township

Union Township Precinct: includes Union Township excluding the city of West Union

West Union First Ward Precinct

West Union Second Ward Precinct

West Union Third Ward Precinct

Westfield Township Precinct: includes Westfield Township and the city of Fayette

Section 3. Effective Date. This ordinance shall be effective after its final passage, approval and publication as provided by law.
