Motion was made by Bradley and seconded by Dolf to approve the quote from Walvatne Electric for installing a Handicap Entrance on the East Side Courthouse Door in the amount of \$3,582. On roll call, all voted aye, none nay, and the motion was carried.

The Board met with Tim Cummings, Custodian, for a brief update.

The Board met with Jon Biederman, Fehr Graham, for an update on the Courthouse Parking Lot Project.

The Board met with Joel Fantz, County Engineer, for a Secondary Roads update.

Motion was made by Bradley and seconded by Dolf to award the contract TAP-R-CO33(122)—8T-33(Turkey River Corridor Trail Project) to Tschiggfrie Exc. Co. in the amount of \$258,672.35 pending receipt of DOT authorization and contract paperwork and also to authorize the chairperson to sign contract paperwork. On roll call, all voted aye, none nay, and the motion was carried.
