Motion was made by Bradley and seconded by Stanbrough to approve the estimate from Northeast Iowa Telephone for a new telephone system and data wiring for the new DHS building at a cost of \$10,635.50. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Bradley and seconded by Stanbrough to approve the Cost Allocation Plan for the year ending June 30, 2019.

On roll call, all voted aye, none nay, and the motion was carried.
