Motion was made by Stanbrough and seconded by Bradley to approve the current agenda. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Bradley and seconded by Stanbrough to approve the minutes from the Monday, June 22, 2020 meeting. On roll call, all voted aye, none nay, and the motion was carried.

The Board met with Vicky Halstead, Assessor, for an update.

The Board met with Marty Fisher, Sheriff and Brenda VandeVoorde, E911 for a discussion regarding a radio system.

Motion was made by Bradley and seconded by Stanbrough to re-appoint Dennis Soppe to the Veterans Affairs Commission for a 3 year term ending June 30, 2023. On roll call, all voted aye, none nay, and the motion was carried.

The Board met with Joel Fantz, County Engineer, for a secondary roads update.

Motion was made by Bradley and seconded by Stanbrough to adopt the following resolution:

Resolution # 444

WHEREAS, the Board of Supervisors, hereafter referred to as “the Board”, believes the Box Beam Bridge Construction Project: BROS-CO33(136)- - 8J-33, hereafter referred to as “the project” is in the best interest of Fayette County, Iowa, and the residents thereof. The project is defined as the replacement of Bridge 151540 on Q Avenue with a Box Beam Bridge; and

WHEREAS, the Board has sought appropriate professional guidance for the concept and planning for the project and followed the steps as required by the Code of Iowa for notifications, hearings, and bidding/letting; and

WHEREAS, The Board finds this resolution appropriate and necessary to protect, preserve, and improve the rights, privileges, property, peace, safety, health, welfare, comfort, and convenience of Fayette County and its citizens, all as provided for in and permitted by section 331.301 of the Code of Iowa; and

IT IS THEREFORE RESOLVED by Board to accept the bid from Brennan Construction Co. in the amount of \$179,894.00 and awards the associated contract(s) to the same;

BE IT FURTHER RESOLVED that all other resolutions or parts of resolutions in conflict with this resolution are hereby repealed. If any part of this resolution is adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution or action of the Board as a whole or any part thereof not adjudged invalid or unconstitutional. This resolution shall be in full force and effect from and after the date of its approval as provided by law; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Fayette County, Iowa, that after receiving the necessary contract documents, including but not limited to, the contractor's bond and certificate of insurance, Joel D. Fantz, P.E., the County Engineer for Fayette County, Iowa, be and is hereby designated, authorized, and empowered on behalf of the Board of Supervisors of said County to execute the contracts in connection with the afore awarded construction project let through the DOT for this county.
