Motion was made by Tellin and seconded by Stanbrough to approve the 2021 DOT Construction Program. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Tellin and seconded by Stanbrough to approve the Fayette County - - Bridge Handrail LED Electrical Lighting, Project Number: L-TRRC Lighting - - 73-33 to Chapman Electric of Elgin, IA in the amount of \$23,357.13 and to authorize the Board Chair or the Vice Chair to sign contract documents. On roll call, all voted aye, none nay, and the motion was carried.
